1. Bidders are bound to accept the orders accordingly.

### 2. Purchase Preference (Centre)

Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid

(a) PERFORMANCE SECURITY: The successful tenderer shall deposit in form of fi xed deposit receipt or bank guaranty form any nationalized bank duly pledged i n the name of the "Director, ICAR-NRC for Orchids, Pakyong" which shall be kep t for a period of 12 months beyond completion of all the contractual obligations. Security deposit has to be submitted within 07 days of award of contract which will be refunded after completion of Defects liability Period. If the supply are not made satisfactorily or terms and Conditions of contract agreement are violated the performance security is liable to be forfeited and if the tenderer withdraws o r amends impairs or derogates from the tender in any respect within the period of validity of his tender the performance security is liable to be forfeited. No interest will be paid on performance security. Security Deposit shall be released after 'Defects liability Period of twelve months from date of completion. During t he defects liabilities period'. The contractor shall replace any item found defecti ve/damaged within ten days of intimation failing which the defective/damaged i tem will be got supplied at the risk and cost of the contractor through any other agency.

(b) DELIVERY AND LIQUIDATED DAMAGES: Supply order has to be fulfilled within 45 days of issue of order. Supply will have to be completed within 45 days or pe riod mentioned in the purchased order. The liquidated damages charges @ 0.5 % per week of the total value of supply order, as a consequence of the delay, sh all be imposed if service made after expiry of delivery period subject to maximu m 10% of the total value of goods/contract value. Quantum of liquidated damage es assessed and levied by the purchaser shall be final and not challengeable by the supplier. Place of delivery (F.O.R) at ICAR-NRCO, Pakyong, Sikkim.

(c) Only those suppliers registered with Central Government/ State Government for sale of plants need apply.

(d) The bidders have to enclose / upload the photo copy of the documents viz R egistration Number with Central Government/ State Government, Pan no/copies of the IT returns for the previous three years, Tin no./GST registration No./ labou r registration no./experience in executing similar works in the last 3 years along with Technical Bid.

(e) The damage of the plant if any during transportation/delay in custom cleara nce etc. shall be the sole responsibility of the supplier and if plant containing pa ckets were turned upside down, damaged during transit or infected with any kin d of microbial infection shall not be accepted at all.

(f) The supplier of the plantlets will have to take the responsibility of import /GS T Tax in country of origin of plantlets, other export import formalities, airport, c argo clearance etc. All quarantine and cargo clearance is the responsibility of th e supplier.

(g) The Supplier cannot charge anything be in terms of relief, money or anythin g for the damage of plants on transit in the airport, on the road, or for any reaso n, including mishandling of plants by airport staff in airports or at time of loadin g unloading of plants of or during transportation/clearance of custom etc.

(h) Supply of plants being very special type supply, where quality of plants is of most important, Security Money will be released only after 12 (twelve) months f rom the date of supply to confirm the quality and variety of plants.

(i) It is mandatory for the supplier to submit the list of varieties dully authentica ted by the tissue culture laboratory.

(j) Sales tax, purchase tax, turnover, insurance or any other tax (if any) on mat erial in respect of this contract shall be payable by the contractor and ICAR-NRC O, Pakyong, Sikkim will not entertain any claim whatsoever in respect of the sa me. Rate quoted should include all charges like delivery charge and miscellaneous expenses. No extra claim above rate quoted will be entertained i n any case.

(k)The Institute will not be responsible for any loss or damage in transit. Insura nce if any required has to be done by the supplier at his own cost.

(I) Time of completion of supply to be adhered to strictly. Specification and parti culars of supply order regarding supply will be adhered strictly. No changes/ Ext ra supply Un ordered supply items will be made by the supplier without prior ap proval of Director NRCO in writing. If made so, then no payment for such change

s/ extra supply will be made by NRCO and no such claim will be entertained in a ny circumstance.

(m) During the defects liability period/warranty period, the supplier shall replac e/supply as directed any or all damaged/defects/defective materials at Supplier' s own risk and cost, to the entire satisfaction, within Ten days of issue of an writ ten notification in this regard failing which the same shall be got done through a ny other agency and cost recovered from amounts due to the supplier/firm.

(n) Inspection:

1) The Director, ICAR-NRCO, Pakyong shall be the final authority to reject full or any part of the supply which is not confirming to the specification and other ter ms and conditions.

2) No payment shall be made for rejected Stores/ Supply. Rejected items must b e removed by the Bidders within 10 days from the date of rejection at their own cost and replaced immediately. In case these are not removed, these will be dis posed at the risk and responsibility of the suppliers without any further notice.

(o) Freight, insurance charges, if any will be borne by the supplier, Similarly sho rtage, pilferage in transit will be sole responsibility of the supplier. The defective supply or service will have to be replaced by the supplier within 10 days without additional freight / transport charge.

(p) The tenderer has to furnish the following details/ certificates in the technical bid: 6. 1. Source of the planting materials with its certified pedigree details. 2. P hytosanitary and CITES certificate against designated diseases of orchids. 3. Tru e to the type Cymbidium full bloom plants, Uniform in size, disease free, healthy and mature.
