- 1. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to inc

rease the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at t he contracted rates. Bidders are bound to accept the orders accordingly.

3. Turnover

6. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

7. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsi bility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is low er), subject to the maximum of quoted GST %.

- (a) PERFORMANCE SECURITY: The successful tenderer shall deposit in form of fixed deposit receipt or bank guaranty form any nationalized bank duly pledged in the name of the "Director, ICARNRC for Orchids, Paky ong" which shall be kept for a period of 12 months beyond completion of all the contractual obligations. Se curity deposit has to be submitted within 07 days of award of contract which will be refunded after comple tion of Defects liability Period. If the supply are not made satisfactorily or terms and Conditions of contract agreement are violated the performance security is liable to be forfeited and if the tenderer withdraws or a mends impairs or derogates from the tender in any respect within the period of validity of his tender the p erformance security is liable to be forfeited. No interest will be paid on performance security. Security Dep osit shall be released after 'Defects liability Period of twelve months from date of completion. During the d efects liabilities period'. The contractor shall replace any item found defective/damaged within ten days of intimation failing which the defective/damaged item will be got supplied at the risk and cost of the contractor through any other agency.
- (b) DELIVERY AND LIQUIDATED DAMAGES: Supply order has to be fulfilled within 45 days of issue of order. Supply will have to be completed within 45 days or period mentioned in the purchased order. The liquidate d damages charges @ 0.5% per week of the total value of supply order, as a consequence of the delay, sh all be imposed if service made after expiry of delivery period subject to maximum 10% of the total value of goods/contract value. - (e) The damage of the plant if any during transportation/delay in custom clearance etc. shall be the sole r esponsibility of the supplier and if plant containing packets were turned upside down, damaged during tran sit or infected with any kind of microbial infection shall not be accepted at all.
- (f) The supplier of the plantlets will have to take the responsibility of import /GST Tax in country of origin o f plantlets, other export import formalities, airport, cargo clearance etc. All quarantine and cargo clearance is the responsibility of the supplier.
- (g) The Supplier cannot charge anything be in terms of relief, money or anything for the damage of plants on transit in the airport, on the road, or for any reason, including mishandling of plants by airport staff in ai rports or at time of loading unloading of plants of or during transportation/clearance of custom etc.
- (h) Supply of plantlets being very special type supply, where quality of plants is of most important, Securit y Money will be released only after 12 (twelve) months from the date of supply to confirm the quality and v ariety of plants.
- (i) It is mandatory for the supplier to submit the list of varieties dully authenticated by the tissue culture la boratory.
- (j) Sales tax, purchase tax, turnover, insurance or any other tax (if any) on material in respect of this cont ract shall be payable by the contractor and ICAR-NRCO, Pakyong, Sikkim will not entertain any claim what soever in respect of the same. Rate quoted should include all charges like delivery charge and miscellaneo us expenses. No extra claim above rate quoted will be entertained in any case.
- (k)The Institute will not be responsible for any loss or damage in transit. Insurance if any required has to be done by the supplier at his own cost.
- (I) Time of completion of supply to be adhered to strictly. Specification and particulars of supply order regarding supply will be adhered strictly. No changes/ Extra supply UN ordered supply items will be made by the supplier without prior approval of Director NRCO in writing. If made so, then no payment for such change s/ extra supply will be made by NRCO and no such claim will be entertained in any circumstance.
- (m) During the defects liability period/warranty period, the supplier shall replace/supply as directed any or all damaged/defects/defective materials at Supplier's own risk and cost, to the entire satisfaction, within T en days of issue of an written notification in this regard failing which the same shall be got done through a ny other agency and cost recovered from amounts due to the supplier/firm.

- (o) Freight, insurance charges, if any will be borne by the supplier, similarly shortage, pilferage in transit w ill be sole responsibility of the supplier. The defective supply or service will have to be replaced by the supplier within 10 days without additional freight / transport charge.
