- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Purchase Preference (Centre)

Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. 3. Turnover

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. 4. Generic

Bidder financial standing: The bidder should not be under liquidation, court rece

ivership or similar proceedings should not be bankrupt. Bidder to upload undert aking to this effect with bid.

5. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

6. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

- (a) DELIVERY AND LIQUIDATED DAMAGES: Supply order has to be fulfilled within 45 days of issue of order. Supply will have to be completed within 45 days or period mentioned in the purchased order. The liquidated damages charges @ 0. 5% per week of the total value of supply order, as a consequence of the delay, s hall be imposed if service made after expiry of delivery period subject to maxim um 10% of the total value of goods/contract value. Quantum of liquidated damages assessed and levied by the purchaser shall be final and not challengeable by the supplier. Place of delievery (F.O.R) at ICAR-NRCO, Pakyong, Sikkim.
- (b) Only those suppliers registered with Central Government/ State Government for sale of plants need apply.
- (c) The bidders have to enclose / upload the photo copy of the documents viz Re gistration Number with Central Government/ State Government, Pan no/copies of the IT returns for the previous three years, Tin no./GST registration No./ labour registration no./experience in executing similar works in the last 3 years along with Technical Bid.
- (d) The damage of the plant if any during transportation/delay in custom cleara nce etc. shall be the sole responsibility of the supplier and if plant containing pa ckets were turned upside down, damaged during transit or infected with any kin d of microbial infection shall not be accepted at all.
- (e) The supplier of the plantlets will have to take the responsibility of import /G ST Tax in country of origin of plantlets, other export import formalities, airport, cargo clearance etc. All quarantine and cargo clearance is the responsibility of the supplier.
- (f) The Supplier cannot charge anything be in terms of relief, money or anythin g for the damage of plants on transit in the airport, on the road, or for any reaso n, including mishandling of plants by airport staff in airports or at time of loading unloading of plants of or during transportation/clearance of custom etc.
- (g) Supply of plantlets being very special type supply, where quality of plants is of most important, Security Money will be released only after 12 (twelve) month s from the date of supply to confirm the quality and variety of plants.
- (h) It is mandatory for the supplier to submit the list of varieties dully authentic ated by the tissue culture laboratory.
- (i) Sales tax, purchase tax, turnover, insurance or any other tax (if any) on mat

erial in respect of this contract shall be payable by the contractor and ICAR-NRC O, Pakyong, Sikkim will not entertain any claim whatsoever in respect of the sa me. Rate quoted should include all charges like delivery charge and miscellaneous expenses. No extra claim above rate quoted will be entertained in any case.

- (j)The Institute will not be responsible for any loss or damage in transit. Insurance if any required has to be done by the supplier at his own cost.
- (k) Time of completion of supply to be adhered to strictly. Specification and part iculars of supply order regarding supply will be adhered strictly. No changes/ Ex tra supply Un ordered supply items will be made by the supplier without prior a pproval of Director NRCO in writing. If made so, then no payment for such chang es/ extra supply will be made by NRCO and no such claim will be entertained in any circumstance.
- (I) During the defects liability period/warranty period, the supplier shall replace/ supply as directed any or all damaged/defects/defective materials at Supplier's own risk and cost, to the entire satisfaction, within Ten days of issue of an written notification in this regard failing which the same shall be got done through any other agency and cost recovered from amounts due to the supplier/firm.

(m) Inspection:

- 1) The Director, ICAR-NRCO, Pakyong shall be the final authority to reject full or any part of the supply which is not confirming to the specification and other ter ms and conditions.
- 2) No payment shall be made for rejected Stores/ Supply. Rejected items must be removed by the Bidders within 10 days from the date of rejection at their own cost and replaced immediately. In case these are not removed, these will be disposed at the risk and responsibility of the suppliers without any further notice.
- (n) Freight, insurance charges, if any will be borne by the supplier, Similarly sho rtage, pilferage in transit will be sole responsibility of the supplier. The defective supply or service will have to be replaced by the supplier within 10 days without additional freight / transport charge.
- (o) The tenderer has to furnish the following details/ certificates in the technical bid: 6. 1. Source of the planting materials with its certified pedigree details. 2. P hytosanitary and CITES certificate against designated diseases of orchids. 3. Tru e to the type Cattleya Hardened plants (12-18 month old) Standards: Uniform, d isease free, healthy, blemish free, turgid.
- 3. Caution declaration for the mortality of the plants during supply be ordered up to 25 percent of bid

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. - 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
